**WHEREAS**, the Greater Flint Health Coalition is a nonprofit Michigan collective impact organization whose mission is to improve the health status of the residents of Genesee County and to improve the quality and cost effectiveness of the health care system in Genesee County;

**WHEREAS**, the Greater Flint Health Coalition Board of Directors has engaged in multiple discussions and reviewed detailed information regarding the state of the City of Flint's water supply and its potential health impacts to all residents.

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, that the Greater Flint Health Coalition Board of Directors requests the release of a Health Advisory from the City of Flint and its Department of Public Works, with urgency, regarding the impact of elevated levels of lead in the City of Flint water supply on all residents, with emphasis on the public health threat to children.
