To be considered, applicant submissions must reflect the following criteria:

- Genesee County-based
- Has provided adequate evidence of 501-c3 status
- Addresses one of the set COVID-19 goals using the proposed strategies
- Addresses project focus population and identified barrier as noted in RFP
- Must be up to date on all prior reporting requirements (*Only applicable to previous GRHEC grantees*)
